<p style="text-align: center;">Heard Ms Manika Roy, learned counsel for the applicant, through video-conference.</p> <p>(2) In this application the following reliefs have been sought to be granted:</p> <p style="padding-left: 40px;"><i>“(a) Admit the original application;</i> <i>(b) To pass appropriate order directing the concerned respondent/ authorities to incorporate/record the name of the applicant in PFO NOS/O22642/2007(Army) dated 28<sup>th</sup> April, 2008 of her husband i.e. Ex. Hav.
