K. Choudhury, Id. advocate for the applicant without having any valid vokalatnama with 'No objection certificate' from Mrs. Sonali Das, Id. advocate.

It is the fact that the applicant filed a fresh vokalatnama in favour of Mr. S. K. Choudhury, Id. advocate with an affidavit for change of advocate on 31.10.2014 and the fresh vokalatnama so filed was duly executed by the applicant with

'No objection certificate' from one Mr. B. S. Das, Id. advocate who, in fact, also accepted the earlier vokalatnama dated 09.04.2013 along with Mrs. Sonali Das, Id. advocate. It is on record that Mr. B. S. Das, Id. advocate also filed one Misc. application (M.A. No.66/2013) on behalf of the applicant on the capacity of advocate-on-record.

That being so, 'No objection certificate' given by Mr. B. S. Das Id. advocate on fresh vokalatnama engaging Mr. S. K. Choudhury, Id. advocate, was taken into account by the office and the name of Mr. S. K. Choudhury, Id. advocate was recorded in the cause list.

Upon due consideration of the grievance of Mrs. Sonali Das, Id. advocate, the matter be placed before the Division Bench for necessary orders.

Let the matter be adjourned and the case record be placed before the Hon'ble Bench on 13.04.2015 for hearing.
