and their statements recorded by the Registrar of this Tribunal, it appears that the applicant and the respondent no. 6 have entered into a compromise and they are presently living together. They have also filed a petition before the learned District Judge of Murshidabad for withdrawing of divorce a petition being MAT Suit No. 06 of 2014 filed by the applicant. There they have also stated that they are agreeing to live together.

In view of above, the compromise petition is allowed. The order impugned dated 18.11.2014 is set aside. The OA stands disposed of accordingly. This compromise petition signed by the applicant and the respondent No.6 will be part of this order. However, the respondent Nos. 1 to 5 will not be liable for refund of the amount already paid to the respondent No. 6.
